ORDER OF REGISTRATION

Upon consideration of the Amended Registration Statement and other papers and documents attached thereto ("Registration Statement") which were filed on behalf of **BALAI NI FRUITAS INC.** (the "Company"), the Commission, resolved in its meeting on 24 May 2022 to favorably consider the same for the registration of **One Billion Four Hundred Nine-Five Million Five Thousand (1,495,005,000) Common Shares with par value of Five Centavos (₱0.05) per share**, in accordance with the requirements of Sections 8 and 12 of the Securities Regulation Code. The shares, to be listed and traded on the Small, Medium, and Emerging Board of the Philippine Stock Exchange, Inc., are broken down as follows:
